The undersigned hereby releases, waives, discharges and covenants not to sue Pals and Paws, Inc. its subsidiaries, its officers and employees, (collectively herein referred to as “releasees”), from all liability to the undersigned, his/her personal representatives, assigns, heirs, next of kin, and the undersigned’s dog(s) for any and all loss or damage, and any claim or demands therefore on account of death of or injury to the person, dog(s) or property of the undersigned, whether caused by the negligence of the releasees or otherwise, while the undersigned and his/her dog(s) are attending, competing, officiating, observing, working for, or for any purpose participating in the event.

The undersigned hereby agrees to indemnify and save and hold harmless the releasees, and each of them, from any loss, liability, damage, or cost they may incur due to the presence of the undersigned and the undersigned’s dog(s) in any way attending, competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

The undersigned further expressly agrees that the foregoing release, waiver, indemnity agreement intended to be as broad and inclusive as is permitted by the laws of the State of Florida, and that if any portion hereof is held invalid, it is agreed that the balance shall continue in full force and effect.

The undersigned knowingly has read and freely and voluntarily signs this release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducements, apart from the foregoing written agreement, have been made.
